BRIEFING

Overview

The RTCS Members and Alternates were presented with the following information and updates on the following: Harris County Transit New Routes using Hurricane Disaster Funds, METRO Mobile Ticketing App Update, Regional Express Transit Framework, Smart Mobility and Automated Vehicles, Regionally Coordinated Transportation Plan Updates. Copies of the presentations are included with this summary.

ACTION ITEMS

ITEM 2A. - Adoption of Agenda

Ms. Vernon Chambers, Chair, Harris County, requested a motion to adopt the agenda.

Action Item Motion: There was no quorum present.

ITEM 2B. – Approval of Meeting Summary

Ms. Vernon Chambers, Chair, Harris County requested a motion to approve the RTC Meeting Summary for the July 11, 2019 meeting as presented.

Action Item: There was no quorum present. This item was deferred until the January 2020 meeting.

ITEM 3. – Public Comment

There were no public comments presented to the subcommittee.

INFORMATION ITEMS

ITEM 4.1 – Harris County Transit New Routes using Hurricane Disaster Funds – Stephanie Nuñez, Harris County Transit.

Ms. Stephanie Nuñez, Harris County Transit, informed the subcommittee Harris County Transit applied for Disaster Recovery Funds due to Hurricane Harvey. They are expecting \$3.8 million in December 2019. These funds will target Harvey affected households. Harris County Transit will introduce 5 new routes in the new future as well as connect to Houston METRO from the Mesa Transit Center, Woodforest/Uvalde and 1-10 East/Uvalde.

ITEM 4.2 – METRO Mobile Ticketing App Update – Denise Wendler, METRO

Denise Wendler and Reginald Brown, METRO, updated the subcommittee on the METRO Mobile Ticketing app. Bytemark Inc. was selected as the vendor. The app will be available in iOS and Android platforms and will be available in the Apple and Google stores. Fort Bend County Transit and Harris County Transit will be participating in a Pilot Project to test the new app.

ITEM 4.3 - Regional Express Transit Framework - Katrina Bayer, Central Houston, Inc.

Katrina Bayer presented a proposal to plan for the development of a regional express bus network with two-way all-day services and a regional branding concept that would also represent the various service providers in the region.

ITEM 4.4 - Smart Mobility and Automated Vehicles - Alan Rodenstein, H-GAC

Mr. Alan Rodenstein, H-GAC, briefed the committee on recent developments in Smart Mobility and Autonomous Vehicles. Included in the elements of Smart Mobility were Mobility as A Service (MAAS), Electric Scooters/Micromobility and Transportation Networking Companies. Mobility as a Service is a customer-based concept for transportation based on tailored travel. Micromobility involves short distance of mainly urban trips in one or two person vehicles. Transportation Networking Companies (TNC's) include shared ride companies such as Uber and Lyft.

Developments in autonomous vehicles included the progress of the initial pilot project at Texas Southern University and other programs in the state were reviewed. A brief prognosis for regional transit in coming years was forwarded.

ITEM 4.5 - Regionally Coordinated Transportation Plan Updates - Kari Hackett, H-GAC

Kari Hackett updated the RTC on recent developments associated with the Regional Interactive Database initiative, the Regional Transit Trip Planner on the Google Transit Platform and the RCTP Statewide Metrics Report. Copies of the Executive Summary for that report were made available.

ITEM 5. – Agency Reports

Ms. Vernon Chambers, Chair, Harris County, invited committee members to briefly give updates on their agency efforts. Updates were provided by several agencies and included the following highlights:

City of Conroe—Ridership is increasing on local and commuter bus routes, they are moving into new office space.

Harris County Transit- New disaster funded routes should be implemented by January 2020. They received a good response from public meetings about the proposed routes. They will be coordinating passenger assistance driver training (PASS?) during the first quarter of 2020.

Fort Bend County Transit- Introduced new Asst. Director, Yvette Maldonado, and confirmed substantial completion goal for new transit facility in October 2019, with grand opening planned for January 2020.

Central Houston- recommended a contact for potential GTFS coordination with the transit provider for the new park and ride service offered by the City of Pearland and reminded members about the availability of the 2019 Downtown Commuter survey.

Thomas Gray, H-GAC -Announced that the new Regional Transit Origin-Destination survey is being planned for the Fall of 2020 to coincide with the 2020 Census. Participation from RTCS members will be needed.

Lydia Abebe, H-GAC announced upcoming FTA webinars for public transportation safety plans on October 24 and October 29th. Registration is required.

Gulf Coast Center noted two new facilities will be available and they have restructured some routes.

Veronica Baxter-Lamb, H-GAC introduced the new Program Manager for the Transportation Demand Management (TDM) team, Jamila Owens. She noted several TDM related activities that will be expanding such as Guaranteed Ride Home.

City of Galveston- Has started several fare initiatives such as free rides for ADA Paratransit riders, veterans and seniors 65 and over. Ridership is growing compared to previous year. Working with FLIX Bus to expand commuter bus trips between Galveston and Houston, planning to reinstate steel wheel trollies with delivery expected in October.

TxDOT-PTN-Coordinated Call for Projects starting Nov. 12th webinars planned for January 2020 timeframe and applications will be due March 27th (to be confirmed), RCTP Continuation funding opportunities will be coming soon, more details will be provided in a subsequent email message.



MOBILITY as a SERVICE (MAAS)

- Shift away mobility consumed as a service
- Where many new travel modes— European and large US cities
- Consumers use MAAS app
- MAAS makes the arrangements for the consumer
- Suburban/rural areas



SCOOTERS AND MICROMOBILITY

- Explosion of Electric scooters in all large cities in Texas
- Except: Houston
- Advantages: short range travel in urban areas
- May connect to transit and first mile/last mile
- Disadvantages: Safety, safety and safety
- Does reduce transit ridership for short trips
- Creates conflicts with pedestrians and cyclists




TRANSPORTATION NETWORKING COMPANIES

- Most used in U.S. of smart mobility applications
- Is it a fully viable operating model?
- DART has developed an extensive First mile/last mile services
- "Go Link" Service / UBER runs on 13 routes throughout region
- Provides quality service at lower cost per DART

AUTOMATED VEHICLES - I

- Early development Generation 2 EZ 10
- Starting to perform practical tasks in passenger transportation
- Beginning product delivery
- Most US vehicles are Level 3
- TSU (uses EZ 10) and Kroeger projects in Houston
- TSU Challenges: weather, accessible, general acceptance, obstacles, speed, maintenance, range (EZ 10 Gen 3 is acc)



AUTOMATED VEHICLES - II

- Other challenges: communication, data management, data security
- Operational obstacles (15 mph)
- Phase II in TSU Houston faces greater challenges
- Other vehicles on the street (Drive Ai) tested in Frisco, TX
- EZ10 used in Arlington pilot between two sports stadiums



WHERE WE ARE HEADED

- Getting out of the initial demonstration phase
- Moving into substantive applications
- In the best of cases providing effective local transportation
- Or they don't work
- More services are inevitably coming
- Usage will expand quickly in coming years



WHAT IT MEANS FOR REGIONAL TRANSIT?

- Fewer resources to implement complex services
- More possibilities will happen
- Community type flexible or first mile/last mile transit service may be mode most affected
- Large non-transit communities will need to look at "new' mobility options






