- 2. *Intersection Safety Audits*-Staff updated the members H-GAC is initiating a program to address high crash frequency intersection in the region. Notice for interested consultants has been initiated. Discussion continued that a consultant has been chosen to assist with the process. Currently, a list is being finalized of the locations that the region will begin work.
- 3. *Regional Safety Campaign* Members were updated that media buys will begin in the Spring. A budget has been outlined with the communication department. Staff continued that they would review and communicate with the committee as material is approved.
- 4. *Roberts Rules of Order*-Staff suggested the committee adopt the use of unanimous consent. Staff examine that unanimous consent is a parliament procedure that is used for noncontroversial issues. The chairman will state "without objection motion is approved". If there is an objection, members can elect to conduct a voice or roll call vote.

- Staff updated the members that six measures that were adopted last year need to be presented to TPC for formal adoption. It was also mentioned that they can officially be used in the MPO transportation planning process.
- The Regional Safety Plan needs to be updated. The last update was 2018, and Safety Plan is updated on the same cycle as the RTP. The next update will due in 2022. The work must begin this year to update the plan.
- Development of implementation action plans is still ongoing. The focus is to continue the areas that were identified in the last regional safety plan. There are still several outstanding focus areas that need implementation plans.
