FEMA

People who suffered from storm damage are eligible for assistance through various programs offered by Federal Emergency Management Agency (FEMA). You are encouraged to apply for assistance regardless of the extent of the disaster you experienced.

Before applying, have the following information ready: Social Security number, insurance information, damage information, total household income, contact information, and direct deposit information (*optional*).

TXHHSC Certification Extensions

Texas Health and Human Services has extended the deadline for Medicaid recertification an additional six months for those living in a declared disaster county so individuals affected by the disaster can continue to receive benefits. Counties affected include Brazoria, Chambers, Colorado, Fort Bend, Galveston, Liberty, Matagorda, Montgomery, Waller, and Wharton County.

Households with certification periods ending in:

- August 2017 will be extended through February 2018;
- September 2017 will be extended through March 2018;
- October 2017 will be extended through April 2018
- November 2017 will be extended through May 2018
