Chair Beckendorff reconvened the Transportation Policy Council at 8:51 a.m. and called the meeting back to order. Chair Beckendorff called for a motion on the action requested. Mayor Kevin Cole motioned to request the Executive Director of H-GAC to extend an offer of employment for the Director of the MPO to our lead candidate as discussed in Executive Session. Commissioner Lesley Briones and Judge Mark Keough seconded the motion. Chair Beckendorff then called for a vote, which resulted in unanimous approval by all members present. Ms. Jamila Owens, H-GAC, informed the Council of the Transportation items that were approved at the H-GAC Board meeting on April 15^{th} .

ITEM 8. 2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) AMENDMENTS, JIM DICKINSON, H-GAC

Mr. Jim Dickinson provided a summary of the proposed revisions to the 2025-2028 Transportation Improvement Program which is included below.

- Update the City of Conroe's FY 2021-2026 Federal Transit Administration Sections 5307, 5310 and 5339 funded Program of Projects for administration, capital, planning, and operations expenditures. Program twenty-three new apportionments and adjust the funding on eighteen existing projects based on the finalized allocations. The City is requesting Transportation Development Credits in lieu of matching funds, where applicable, to leverage the federal funds.
- Add \$63.7M of federal Surface Transportation Block Grant funding, with a 20% local match, to two segments of the City of Pearland's Mykawa Road widening projects (MPO IDs 7602, 17082) due to increased cost estimates since the original programming in 2014 and 2015.

- Program two U.S. Department of Transportation RAISE discretionary grant program awards made to the TxDOT Houston District to construct intermodal facilities in Angleton (MPO ID 19367; \$7.0M) and in Freeport (MPO ID 19368; \$15.2M).
- Program the City of Mont Belvieu's Traffic Management Center construct project (MPO ID 19361) selected in the Project Selection Process in FY 2027 with \$2.8M of federal Congestion Mitigation/Air Quality and local matching funds.
- Program the engineering phase of Montgomery County's SH 99 frontage road and turn lane construct project (MPO ID 19352) selected in the Project Selection Process in FY 2026 with \$750K of state Pass-Through Finance funds.

Additional Federal Transit Administration Formula Funded Amendments

- Update METRO's FY 2024 Federal Transit Administration (FTA) Sections 5307, 5310, 5337 and 5339 funded Program of Projects in FY 2025 (MPO IDs 19102-19110) applying Transportation Development Credits (TDCs) in lieu of matching funds to leverage the federal funds.
- Program two new Harris County Housing & Community Development's FY 2024 FTA Section 5307 funded projects in FY 2025 (MPO IDs 19454,19455) for transit operations and capital expensed using TDCs in lieu of matching funds to leverage the federal funds where applicable.
- Update Fort Bend Public Transportation's FY 2024-FY 2028 FTA Sections 5307 and 5310 in FY 2025 (MPO IDs 18836, 18926, 18930, 18342, 18830, 18831, 18832, 18840) applying TDCs in lieu of matching funds.
- Update The Woodlands Township's FY 2020-FY 2025 FTA Section 5307 Program of Projects in FYs 2025-2028 (MPO IDs 18636, 18640, 19456-19472) applying TDCs in lieu of matching funds.
- Update the METRO's Missouri City Park and Ride project (MPO IDs 18167, 18924) with modifications of the facility, limits, scope and funding.

Mayor Joe Zimmerman made a motion, and the motion was seconded. Chair Beckendorff then called for a vote. The Council voted and approved both resolutions. ITEM 10. MOBILITY PLANNING: FIFA WORLD CUP 2026, MR. JOSHUA SHIDELER, HOUSTON TRANSTAR

Mr. Joshua Shideler, Houston TranStar, made a presentation to the Council on the mobility planning being done to prepare for the FIFA World Cup 2026. Mr. Shideler informed the Council that Houston would be a host city for seven matches and one of the world's largest sporting events in history. Effective mobility planning is critical to keep residents and visitors moving and described the various partners involved in planning for the World Cup. A discussion occurred after the presentation. ITEM 11. UPWP AMENDMENT- HOUSTON FIFA WORLD CUP 2026 TRANSPORTATION PLANNING AND MODELING, DR. NEELY KIM, H-GAC AND MR. JOCHEN FLOESSER, H-GAC

Dr. Neely Kim, H-GAC, presented the UPWP Amendment -Houston FIFA World Cup 2026 Transportation Planning and Modeling for the FIFA World Cup to the Council. Dr. Kim introduced Mr. Jochen Floesser, Director, H-GAC, to give further details on this amendment to the Council. Mr. Floesser described the project's proposed timeline, effort, budget, scope of work and anticipated results. The proposed project is not focused on the area around NRG Stadium and the urban core in addressing the World Cup transportation challenges. The goal is to assess the effectivity of traffic flow from and to the main venue to other event hotspots and to make actionable recommendations to the stakeholders regarding their transportation plans as well as connectivity to areas outside the urban core. Mr. Floesser described the timeline for the project in detail and described the outcome and deliverables. A discussion occurred after the presentation. Dr. Kim asked for approval of the UPWP Amendment – Houston FIFA World Cup 2026 Transportation Planning and Modeling and UPWP Resolution No. UPWP 2025-2

- 1. Adding new activity for a consultant to be utilized to develop transportation scenarios and conduct modeling to address mobility challenges associated with FIFA World Cup 2026.
- 2. Adding Transportation Planning Funds (TPF) to Fiscal Year 2025, Task II subtask 2.1.a in the amount of \$500,000.00 for the utilization of a consultant.

A robust discussion occurred after the request. Chair Beckendorff called for a motion. A motion was made by Commissioner Lesley Briones and seconded with amendments. Chair Beckendorff then called for a vote. The

ITEM 12. REGIONAL DEMOGRAPHIC FORECAST, DR. PRAMOD SAMBIDI, H-GAC

Dr. Pramod Sambidi, H-GAC, gave a presentation to the Council on the Regional Demographic Forecast. Dr. Sambidi informed the Council the overall U.S. population was on a downward trend since 2020 compared to previous projections. There are three reasons for this decline. 1. Declining birthrates 2. Aging population 3. Temporary disruption to immigration caused by the Covid 19 Pandemic. Down by 7.8%, this is from the Census bureau. The population projections for the state of Texas from the Texas Demographic Center is down by 14% compared to their 2018 projections. The population projection for the H-GAC 8 counties is 10.7 million people by 2050. The new projection is down by 5% compared to our previous projection from 2018. Dr. Sambidi proceeded to describe various projections and sources. The population distribution from 2020 to 2050 will add 3.7M people to our region. A discussion occurred after the presentation. ITEM 13. TRANSPORTATION CONFORMITY UPDATE, STEPHEN KEEN, H-GAC AND DR. MAGGIE ISIED, H-GAC

Mr. Stephen Keen, H-GAC, gave an update to the Council on the RTP Project listing. Staff has contacted all the sponsors who have projects on RTP list. Staff received updated information from majority of sponsors. Staff coordinating with remaining sponsors. 70 plus sponsors for over 1,000 plus projects. Staff has received information regarding the addition of projects, removal of projects and project updates. A new project list is available today on the H-GAC website. An RTP amendment will be ready for TAC/TPC approval by Fall 2025 after conformity analysis and a public comment period.

Dr. Maggie Isied, H-GAC, made a presentation on the Conformity Update. Dr. Isied gave the Council an overview of Transportation Conformity. A federal requirement to ensure that air quality in nonattainment regions like ours is not negatively impacted by transportation planning efforts. Our region is currently in nonattainment for two 8-hr Ozone Standards.

- 2008 8-hr Ozone standard (75 ppb) Severe designation
- 2015 8-hr Ozone standard (70) ppb) Moderate Designation

Conformity analysis is required for our region. Dr. Isied briefed the Council on the conformity process which consists of two steps and the current status of the Conformity timeline.
