

The Garth Rd. Widening Project, CSJ 0912-72-359 initiated with an Advanced Funding Agreement (AFA) which was executed in 2016 and requested to be amended to shift federal funds to Phase A and B construction in July 2020 through the Houston Galveston Area Council Transportation Improvement Plan (HGAC TIP) process. We understand this process is still moving forward, and we look forward to a successful amendment of the project funding and subsequent revised Advanced Funding Agreement.

The City of Baytown has since acted on the intent of the change, and has funded and began the design and utility coordination and relocation of utilities as part of the project. The plans are now at the 60% design status, and are in review with the TxDOT Houston District office.

The project is currently on schedule for a February 2022 design completion, at which time the five (5) month review will occur. This will bring the completion of that design effort to July 2022, with an expected let date in late September 2022. 
