

**11A. ADMINISTRATIVE AMENDMENTS TO THE 2021-2024 TIP AND 2045 RTP**

**Summary**

Consistent with Transportation Policy Council guidance, administrative modifications to the following projects are being made this month:

- Make slight adjustments to the limits of TXDOT Houston District SH 35 tollway construction project (MPO ID 209/CSJ 0178-09-020) to make them match TXDOT schematic documents.
- Update the scope of work at the recommendation of the Federal Transit Administration to state that preliminary engineering was done for the Gulf Coast Transit District's Texas City Park and Ride construction project (MPO ID 16222/CSJ 0912-73-208).
- Assign TXDOT Control-Section-Job number 0912-73-213 to Galveston County's Pelican Island bridge replacement project (MPO ID 18085).
- Assign TXDOT Control-Section-Job number 0912-00-629 to METRO's FY 2021 CMAQ Regional Vanpool Program project (MPO ID 18361/CSJ 0912-00-645).


