RESOLUTION BY THE CITY COUNCIL OF THE CITY OF CLEAR LAKE SHORES, A "TYPE A" GENERAL-LAW MUNICIPALITY CREATED PURSUANT TO THE LAWS OF THE STATE OF TEXAS, FOR THE SUPPORT OF A JOINT PROJECT WITH THE CLEAR LAKE SHORES ECONOMIC DEVELOPMENT CORPORATION, A LOCAL GOVERNMENT CORPORATION CREATED BY THE CITY OF CLEAR LAKE SHORES

WHEREAS, the City and the Economic Development Corporation (EDC) both agree that the reconstruction of the Clear Lake Road Bridge is a critical project due to the existing state of good repair of the existing bridge and the lack of accommodations for pedestrian, bicycle, and Americans with Disabilities Act access;

Section 1. The Mayor and the City Council of Clear Lake Shores, Texas hereby authorizes the submittal of all required data and information to support a request for the pursuit of discretionary funding to facilitate the Bridge Replacement Project.

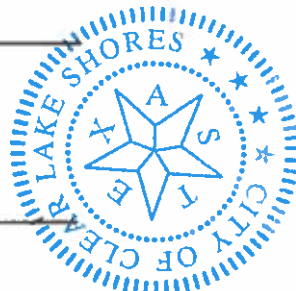

Section 1: The EDC hereby authorizes the commitment of \$500,000 in non-federal resources to provide the 20% local match requirement for the Clear Lake Road Bridge Project.
