RESOLUTION OF SUPPORT AND FUNDING COMMITMENT FOR HOUSTON-GALVESTON AREA COUNCIL TRANSPORTATION IMPROVEMENT PROGRAM SUBMITTALS WITHIN MONTGOMERY COUNTY PRECINCT FOUR

WHEREAS, the Houston-Galveston Area Council has issued the 2018 Transportation Improvement Program (TIP) Call for Projects;

WHEREAS, Montgomery County Precinct Four has identified two projects (**Exhibit A**) which are critical for mobility, safety, and connectivity within the Precinct;

WHEREAS, Montgomery County Precinct Four desires to apply for discretionary grant funding in order to complete the project and to further leverage bond proceeds;

WHEREAS, Montgomery County has the financial, technical, and legal capacity to enter into a grant agreement and to deliver the project per the grant requirements, if awarded;

WHEREAS, Montgomery County is committed to providing the required local share commitment as established by the Houston-Galveston Area Council; and

WHEREAS, Montgomery County agrees to maintain and operate the project improvements for their useful life, and/or utilize existing maintenance agreements with partner agencies, if the Projects are funded and constructed.

NOW, THEREFORE BE IT RESOLVED THAT THE MONTGOMERY COUNTY COMMISSIONERS COURT:

Section 1: The Montgomery County Commissioners Court hereby authorizes the submittal of all required data and information to support a request for the pursuit of discretionary funding to facilitate the Projects.

Section 2: The Montgomery County Commissioners Court hereby authorizes the commitment of non-federal resources to provide the local match requirement for the Projects.

Section 3: Montgomery County Commissioners Court hereby recognizes that Montgomery County agrees to maintain and operate the Projects for their useful life, and/or utilize existing maintenance agreements with partner agencies if the Projects are funded and constructed.

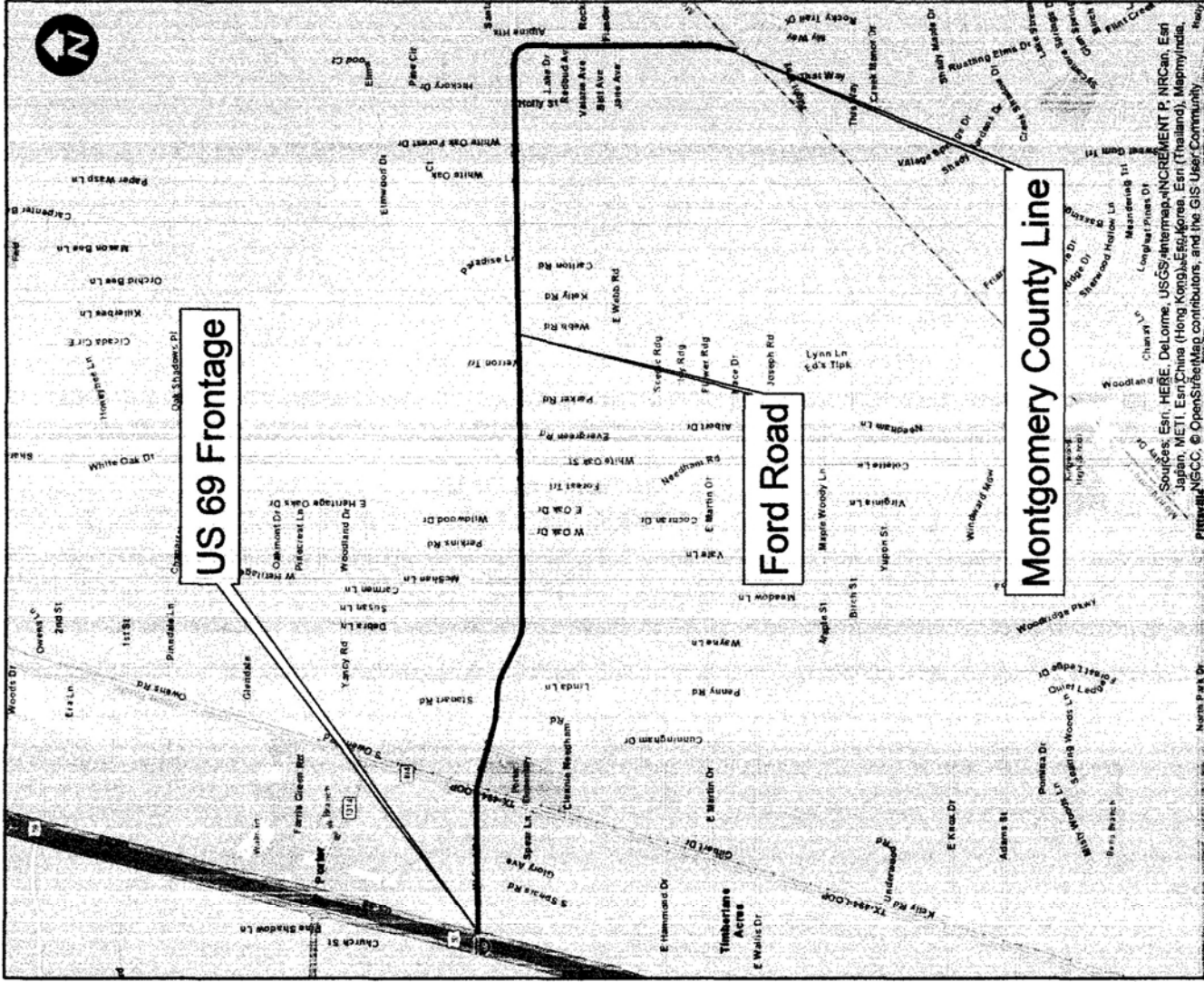

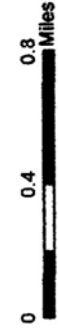


Exhibit A
