The Texas Medical Center (TMC) fully supports Hermann Park Conservancy's Hermann Park Bike Network project presented for the 2018 TIP Call for Projects.

As a park neighbor, we believe the proposed bike path connections through Hermann Park are vital to connecting major bike networks together, including the ever-growing TMC campus, via both on-street and off-street bike trails. We have been coordinating with Hermann Park Conservancy to connect our bike network and ensure we are both integrated into the overall Houston Bike Plan.

TMC is the largest medical center in the world, serving more than 10 million patient visits each year and we proudly employ over 110,000 people who live in Houston. Many of our employees commute via bike to and from TMC each day.

TMC is also working on developing a new translational research campus, TMC3, which will be another link in the chain of a major innovation investments in Houston from downtown, to the Midtown Innovation District that Rice University is working on, to the main TMC campus and TMC3 – all connecting through Hermann Park. The creation of safe and easily connected bike trails is integral to achieve the overall vision of the innovation district and commuter biking in Houston. Hermann Park is a central link in the overall bike network, so TMC fully supports TIP funding for this important project.

Dear Alan,

Rice University fully supports Hermann Park Conservancy's Hermann Park Bike Network project, being presented to HGAC in response to its 2018 Traffic Improvement Plan Call for Projects.

As a park neighbor, Rice University believes the proposed bike path connections through Hermann Park are vital to important goal of knitting major Houston bike networks together, including those that run to and through the Rice campus, the Texas Medical Center and the central business district, and that the proposed trails will help to integrate all of these networks more fully into the overall Houston Bike Plan. This continuity is crucial to multiple organizations' collective efforts to make our city safer and more connected for pedestrians and bikers.

In support of the recommendations of Mayor Turner's Technology and Innovation Task Force, Rice University has embarked on a major project to create an Innovation district that will reimagine a multi-acre land parcel in Houston's Midtown neighborhood, approximately 1.7 miles from Hermann Park and Rice's campus, 2 miles from the Texas Medical Center, and just over 2 miles from Houston's central business district. This entire corridor is known as the Houston Innovation Corridor and is served by METRORail's Main Street Red Line and a currently fragmented system of bike lanes. Rice University is heavily investing in the redesign of this area and supports all efforts to encourage connectivity between technology innovation hubs along the innovation corridor via transit and bikeways. Technology developments of this kind will only attract more knowledge workers and innovation industries to Houston, and support of the Hermann Park Bike Network supports this by helping to realize the vision of the overall Houston Bike Plan.

Rice University supports the work of the Hermann Park Conservancy and applauds its efforts toward increasing the quality of life in Houston and being part of a greater plan for this city's future.
