Re: Conroe Connection 2018-2021 Transit Asset Management Plan

SERVICE DESCRIPTION

Conroe Connection public transportation was launched January 2015 and is a department of the City of Conroe. The service includes two fixed routes with ADA complementary paratransit service. Conroe Connection is supported with funds from the Federal Transit Administration (FTA), the Texas Department of Transportation (TxDOT) and the City's General Revenue Fund.

The days and hours of operation are Monday through Friday; from 7:00 am to 7:00 pm. Oneway fares are \$1.00 and \$.50 for seniors (over 65), students, children ages 6 to 12, persons with disabilities and Medicare cardholders. The service is free for children under 6 years accompanied by an adult.

CAPITAL ASSETS

As of February 6, 2018, Conroe Connection has a revenue vehicle fleet of six (6) active vehicles. There are four (4) Type 11, Low Floor Buses, and two (2) Type 7 passenger vans. Appendix A, Asset Portfolio, shows the detailed information about each vehicle. These vehicles provide service to the Conroe Connection Fixed Route Service and Americans with Disabilities Act (ADA) Complementary Paratransit service.

CONDITION ASSESSMENT

The FTA Transit Asset Management Final Rule: Subpart D – Performance Management § 625.41 defines the objective standards of State of Good Repair (SOGR) as follows.

"A capital asset is in a state of good repair if it meets the following objective standards:

(a) The capital asset is able to perform its designed function;

(b) The use of the asset in its current condition does not pose an identified unacceptable safety risk; and

(c) The life-cycle investment needs of the asset have been met or recovered, including all scheduled maintenance, rehabilitation, and replacements."

CONROE CONNECTION SOGR POLICY

In order to keep the fleet in a SOGR, Conroe Connection vehicles are assessed by a third-party vehicle maintenance contractor at routine maintenance intervals and evaluated for condition throughout their established life cycle. Conroe Connection neither owns nor operates maintenance facilities. No half-life rehabilitations are performed on Conroe Connection fleet vehicles. Once the current fleet vehicles have exceeded their useful life, they will be decommissioned and sold at auction, or provided to the third-party transportation contractor to be used as spares. Currently, the Conroe Connection fleet SOGR is 100%. Appendix B, Condition Assessment, shows the most recent assessment of the fleet.

MANAGEMENT APPROACH

Conroe Connection's Management Approach to support annual capital budgeting and program of projects prioritization is an in-house excel spreadsheet that:

- Establishes the number of active vehicles by vehicle type (Type 7, or Type 11) for each program;
- Calculates the average number of miles per vehicle based on the program's prior year actual service and the number of vehicles in the fleet;
- Applies average miles to each vehicle annually, which results in an annual mileage estimate per vehicle based on year of purchase;
- Identifies vehicles that have exceed their useful life based on age and estimated mileage;
- Counts the number of vehicles that are in a State of Good Repair (SOGR) based on age and mileage parameters; and
- Calculates the SOGR percentage based on the recommended fleet size.

INVESTMENT PRIORITIZATION

Once vehicles have exceeded their useful life, they will not be replaced. All future vehicle replacement will be the responsibility of the third party transportation service provider.
