- Meeting Summary:** The public meeting allowed for comments and questions regarding the project limits, right-of-ways, environmental environmental issues and project implementation time line.

Background

Public involvement is a vital component of the National Environmental Policy Act (NEPA) process. The Texas Department of Transportation (TxDOT) adopted a Public Involvement Program that offers opportunities for the public to participate in the process. A public meeting was held on August 16, 2011 in Houston, Texas. TxDOT received comments from the public meeting regarding design alternatives for Tanner Road from Beltway 8 to Hempstead Highway. Public involvement is a continuous process and the participation of agencies, businesses, public representatives, and concerned citizens is always encouraged.

Description of Meeting

On August 16, 2011, an open house meeting was held to discuss the proposed expansion of Tanner Road from Beltway 8 to Hempstead Highway as the next phase of the NEPA public involvement process. The meeting took place at R.L. & Cora Johnson Community Center in Houston, Texas.

The public meeting was announced and advertised through a variety of methods. Thirty days

prior to the meeting, TxDOT engaged in an extensive effort to announce the meeting through mailings and published advertisements. Notices announcing the public meeting time, location, and purpose were mailed to a list of landowners with property adjacent to the existing right-of-way (Appendix A). An informational letter also announcing the public meeting time, location, and purpose was sent to local elected officials (Appendix B). Advertisements (Appendix C) were published 30 days and 10 days in advance in newspapers with local and city-wide circulation.

As meeting attendees arrived, they were asked to sign-in (Appendix D) and each person was provided with a copy of the public meeting information sheet and a blank pre-addressed comment form (both in Appendix E). The sign-in sheets indicate that 28 citizens and 4 elected officials attended the meeting.

The meeting format was an open house session between 6:00 p.m. and 8:00 p.m. to allow the public to view reference materials and maps, and the opportunity to visit with project team members. Photographs from the public meeting are in Appendix F. The public was encouraged to visit information stations for design, environmental constraints, and right-of-way acquisition procedures. Several engineers, environmental professionals, and right-of-way experts were available at each station to provide information and answer any questions. Throughout the meeting, attendees had the chance to submit written comments. Comment tables and comment drop boxes were set up in the open house area. Written comments could also be mailed-in or e-mailed by August 30, 2011.

Summary of Comments

By the conclusion of the comment period, City of Houston received ten (10) written comments (Appendix G). The comments received were generally in regards to design modifications or direct impacts associated with each design option. Of the comments received, five (5) were in favor of alternative 4 as presented at the public meeting. Additionally, comments were received stating concerns regarding traffic, four (4) requested adding traffic lights at Tanner Road and Teague Road and at Tanner Road and Triway Ln. Two (2) commented on 80' ROW suggesting no median or sidewalks and two (2) commented on keeping the Oak and Pecan trees north of R.L. and Cora Johnson Park. Each comment, whether written or emailed, was considered equal. Each response to the comments can be viewed in the "Response to Comments" (Appendix H) section of this report.

Based on preliminary environmental studies and comments received during the public meeting, TxDOT will determine which Alternative (1, 2, 3, or 4) will be the Recommended Alternative. Once determined, the Recommended Alternative will be carried forward in the Environmental Assessment for further studies. The engineering, social, economic, and environmental studies will be conducted for the Recommended Alternative to indicate the significance of the proposed impacts on the human or natural environment.

The City of Houston (COH) and Texas Department of Transportation (TxDOT) will conduct a public meeting regarding the proposed widening of Tanner Road from Beltway 8 to Hempstead Highway in Houston, Harris County, Texas. The meeting will be held on August 16, 2011 from 6:00 pm to 8:00 pm at the R.L. and Cora Johnson Community Center (formerly Carverdale Community Center) located at 9920 Porto Rico, Houston, TX 77041. The meeting will be held in open house format.

The purpose of the meeting is to gather public input on proposed improvements to Tanner Road including reconstructing portions of the road between the project limits, widening from 2 to 4 lanes, and the construction of a storm water management system. The proposed project is approximately 1.8 miles long.

Additional right-of-way would be required for the proposed action; however no displacements would be necessary. Personnel from the City of Houston Real Estate Branch will be available to discuss the procedures, benefits and programs, and will provide other needed information regarding land acquisition.

Exhibits showing aerial photography, proposed design, and other information related to the proposed project will be presented at the meeting. Public comments are encouraged. Representatives from COH, TxDOT and the project team will be available to answer questions.

Information from the public meeting will be on file and available for review at the City of Houston, Department of Public Works & Engineering, 611 Walker, Houston, Texas 77002, and at TxDOT's Houston District Office, 7600 Washington Avenue, Houston, Texas 77007. City of Houston offices are open 8:00am to 5:00pm, excluding national holidays, and TxDOT office are open 8:00am to 5:00pm, excluding state holidays.

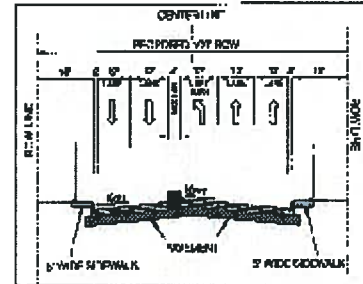
PROJECT VICINITY MAP

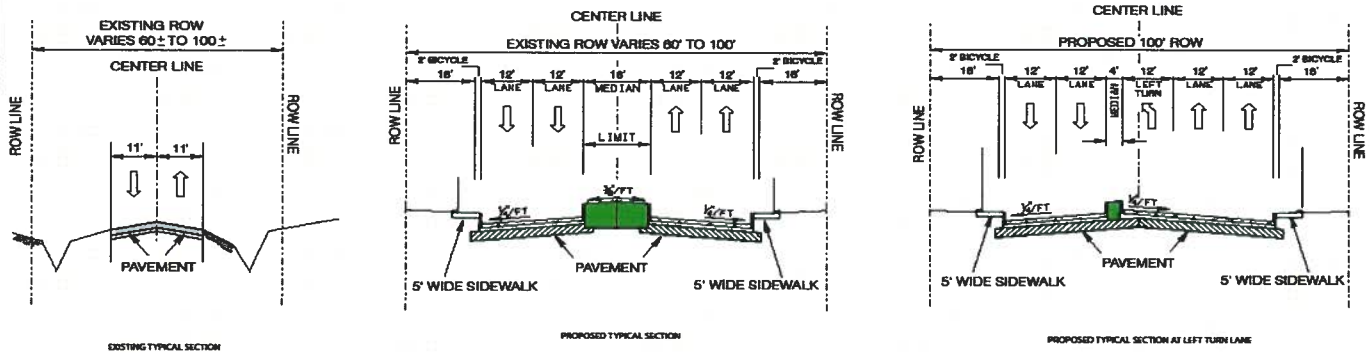

Appendix I:
Response to Public Comments

Responses to Comments on Tanner Road from Beltway 8 to Hempstead Highway Public Meeting

The public comment period for Tanner Road was open from August 16, 2011 to August 30, 2011. The public was invited to submit comments during the meeting, by mail, or electronically. In total ten (10) comments were received from residential and business property owners. Overall, most comments were in favor of the proposed project. Several current issues such as flooding, traffic control, and pavement condition were addressed in the public comments. Any design alternative (other than the 'no-build') will improve the current traffic control and maintenance issues that are associated with the project alignment. As far as the current flooding issues, this project will not create any additional flooding problems in the area.

The purpose and need of the project was conveyed to the public during the meeting and their support of the project was apparent. The 'no build alternative' was never suggested by any comments and several comments stated that they are pleased with the idea that the project will be moving forward.

Four project alignment alternatives were displayed for the public during the meeting. Per the public comments, alternative 4 was shown to be the preferred option for both the city and county portions of the project. Alternatives 1, 2, and 3 were generally not supported by the public comments. Several local residents and adjacent property and business owners were in favor of alternative 4 for the reason that it does not infringe on current property boundaries as much as the other alternatives. In addition, Alternative 4 does not impact a series of large, old growth oak and pecan trees that are located along the north side of Tanner Road opposite the R.L. and Cora Johnson Park. These trees are visually appealing to the community and appear to be the only old growth trees of their size located within the surrounding area. It is anticipated that removing these trees would result in a negative view of the project from local community residences. Alternative 4 proposes the taking of a small portion of parkland. In view of the comments received by the public, it is in the best interest of the project and the public to submit for a Section 4(f) to acquire a small portion of the parkland and construct the project using alternative 4. The comments presented in the meeting back up the environmental and engineering review that was constructed for this project. By incorporating another alternative other than alternative 4, environmental justice issues, sensitive habitat issues, and possible property displacements will occur.
