A couple of quick questions:

- 1. Dairy Ashford: What are the correct proposed limits for the TIP Call project? The table below has the bayou as the southern limit, but the application discusses the project all the way to Westheimer.
- 2. Fuqua: Is the a reconstruction only or added capacity (widening) project? The application is not clear.
- 3. Gessner (and Dairy Ashford?): The travel demand model will not provide an estimate of intersection delay attributeable to a grade separation at Westheimer. If this is part of the proposal, we would suggest using Synchro/Vissum or some other microsimulation package to assess the project's affect on intersection delay.

Please let us know these issues should be addressed.
