The Architecture and Engineering Division respectfully requests that Commissioners' Court authorize submission of a grant application to the Houston-Galveston Area Council for potential inclusion of funding in the Transportation Improvement Program (TIP) in the amount of \$4,369,550.00 for the construction on Fairmont Parkway in Precinct 2. The purpose of the TIP program is to distribute federal funding to selected transportation projects of regional priority.

If funds are awarded, Precinct 2 would be required to commit \$1,579,660.00 for related expenses as follows:
